Kent Community Foundation – Youth Social Action

Grants of between £1,000 and £5,000 are available to local voluntary, community and social enterprise organisations working in Kent for projects which deliver social action opportunities amongst young people aged 10 to 20 years old when the programme begins, or 25 years for disabled people.

The Kent Community Foundation is seeking to support projects ranging from traditional social action such as regular youth volunteering at a care home to newer ways of creating positive social impact such as micro-volunteering activities where individual young people decide what they want to do. Core costs are eligible if the other criteria are met, including how the project meets the principles of great youth social action.

The Foundation anticipates that projects will increase empathy and understanding of the positive impact young people make and bring benefits to older people, children, local business, schools and those that supported / tutored the young people.

The Foundation will prioritise projects that:

- Seek to increase participation from young people from lower social economic groups and people who might not usually take part in social action
- Engage new volunteers
- Embed skills in young people / the wider community while delivering. For example, listening skills, maths and English, cooking, media and communications, evaluation and capturing success
- Clearly demonstrate principles of great youth social action. For example: an enjoyable project that enhances young people's social lives, provides the opportunity to meet new people, positively impacts the wider community and develops longer term connections between volunteers and the wider community
- Have a plan to measure and report positive changes made
- Demonstrate sustainability beyond the life of this grant

Sport England - Tackling Inactivity and Economic Disadvantage

From April 2017 Sport England will be accepting applications from a wide range of community organisations for the second round of its £3 million inactivity fund. The fund will be available for projects which use sport and physical activity to improve lives and communities, and will support inactive people who have little income and are therefore economically disadvantaged. Two pots of funding will be available:

- A £2 million fund to support larger projects with funding of up to £500,000. This funding will be given to projects which target those who have little disposable income. Beneficiaries will likely live very ordered lives but find it hard to find time for physical activity or feel that being active is just not for them
- A £1 million fund for projects seeking funding of between £10,000 and £100,000. This funding will focus on those who are far less likely to have a steady income, or any income at all, living more chaotic lives with additional challenges. For example, they may have an offending background, be dealing with alcohol or drug misuse, or facing mental health issues

Sport England says it knows that sport and physical activity can be extremely powerful in supporting positive social change for communities and individuals, that could mean using sport to improve someone's mental wellbeing, help drive down crime rates in an area, or reduce social

isolation in rural communities.

The Prince's Countryside Fund

Grants of up to £50,000 (to a maximum period of three years) are available to not-for-profit organisations, charities, social enterprises, Community Interest Companies, companies limited by guarantee, and unincorporated associations in the UK for projects that have a long-term positive impact on rural communities, helping those that live and work there to sustain the countryside by tackling key rural issues. The objectives for the Spring 2017 round are as follows:

National Churches Trust Grant Programmes

Biffa Awards - Recreation and Community Buildings

Grants of between £10,000 and £75,000 are available for not-for-profit organisations to improve community spaces and places for outdoor recreation (green spaces, woodland walks, play areas, sports facilities and community gardens).

The project must be located within 5 miles of a significant Biffa operation or within 10 miles of an active Biffa Landfill site. You can check the project's postcode using the Postcode Checker on the Biffa Awards website. The project's site must also be within 10 miles of any licensed landfill site (visit the Environment Agency website). The total cost of the project should be less than £200,000 and there must be a minimum of 104 days of full public access to the project per year.

Veolia Environmental Trust

Grants of up to £75,000 are available for capital improvement projects located within the proximity of a qualifying Veolia site. Match funding of at least 20% is required, and applicants requesting grants of £40,000 or more require a Third Party Contribution. Projects should fall under one of the following categories:

- Community buildings and rooms
- Outdoor Spaces
- Play and recreation
- Supporting Biodiversity

Constituted not-for-profit organisations can apply as long as their project is located within five miles of a Veolia Environmental Services facility. This could be a Veolia landfill site or a civic amenity site, or a transfer station or depot. Use their Postcode Checker to confirm geographic eligibility.

The Shed project is targeted at men of all ages and ex-service personnel and is open to women. Sheds offer those engaged in the project, the opportunity to socialise, find friendship, share and learn skills, support each other and their communities.

The programme is not prescriptive on what type of activity a Shed should offer. Funding is available for capital expenditure to purchase equipment, pay towards premises costs (rent/bills), promotion and activities. Activities have included allotments, fishing, and boating.

More Than A Pub: The Community Pub Business Support Programme

Finance packages of loans and grants are available to communities that are considering taking on the responsibility for and ownership of their local pub, through purchase or long-term lease. A comprehensive package of business development support, advice and loan and grant funding has been developed to assist community pub businesses consider their viability at all stages of their development which includes:

- An advice line, events, workshops, peer-to-peer study visits and business development advice
- Flexible bursary awards of up to £2,500 (inclusive of VAT) to fund pre-feasibility costs such as public consultation and valuations
- Combined loan and grant funding up to £150,000. This will not exceed £75,000 in grant contribution. The average grant is expected to be about £37,500. The average loan may be around £42,800

Grants must be used for projects which deliver improvements to the physical environment and/or encourage the use and long-term stability of outdoor spaces. Examples include:
